

## The Payoff of Early Public Engagement Ron Mills



We've heard it all before: prospecting is changing. Some say for the better, some say for the worse. Whatever your perspective, the time of the social justice warriors is upon us.

I was asked years ago to take part in a public engagement initiative planned for prospectors and I flatly refused. My arguments were as valid then as they are today. Statistically, one in 10,000 mineral exploration properties turns into a mine. Why should prospectors, at the bottom end of the exploration and mining hierarchy, be given the responsibility of public engagement and stirring people up when the "hit by lightning" odds of eventual development really didn't matter? Prospectors don't really have the outreach skills, temperament or resources to engage, and its a huge risk for them and their projects. And with the staking, permitting, landowner permissions, report writing, DNR contact for Crown access, data compilation of past work, and base map making exercises prior to the first visits taking away from actual prospecting, how much time is left for the real work?

I thought I was proven right when some prospectors recently involved in drilling made the effort to engage the few locals in the quiet neighborhood close to their target as part of the process. A couple of locals emerged that were outraged such activity could take place near their home. They did their best to cause a stink, calling politicians, pressuring other locals to take their side, in any attempt to stop the drill spinning. I had argued this would happen as part of the "too early" engagement process. The drilling was done and the results were relatively inconclusive, as is almost always the case in the exploration industry. One down, 9,999 to go. Neighborhood back to sleep. People running around with hair on fire for nothing.

DNR recently initiated a request for proposals over a piece of closed ground in the Cobequid Highlands. This elicited a response from a few anti-resource development activists, some local, others from farther afoot. Some organized and claims were made that DNR withheld public information, misled the public, and prepared for proposals in secret, since some felt they caught wind of the initiative very late in the process.

To DNR's credit, they had reached out months earlier to politicians, including the MLA and regional councilors for the area, some of whom took some effort to win over. A few activists cried foul. They argued this had been done behind the backs of locals, but were shown a local newspaper article, also dated months earlier, produced from an interview with a DNR spokesperson describing the proposed project in relative detail. No secrecy. No backroom deals. All project data have been released publicly. Curiously, when one activist arguing public money had been spent on data that hadn't been released found out a data release from the

project was imminent, he argued the data release should be stopped. Obviously, you're never going to win over everyone. But in this case, DNR's efforts to engage early have paid off.

I can't say when, what level or how one should engage. In the first case study, engagement produced some friction that, in the end, didn't matter either way. But there is no denying that in the second case study, early engagement may have saved the project.

I originally hated the idea of prospectors doing public engagement, but I'm slowly changing my tune. Social justice warriors have many tools to use against the mineral exploration industry. Early engagement well delivered, it seems, might be one tool prospectors can use to their own benefit.

### Membership concern?

Casual observation makes me think NSPA membership is gradually getting older and fewer, much like the population of NS. Fortunately, this is not a universal truth. The NSPA does have newer and younger members as well. Fortunately, many high school students have an interest in mineral development and prospecting. I had the pleasure of touring a mine site with IB students of YCMHS and later hearing their presentations on resource development. The reports were well researched and free of bias. The popularity of the NSPA annual panning clinic and the NSPA display at the Parrsboro Gem and Mineral Show indicate strong general interest as well.

More people would be attracted to prospecting if prospecting courses could be repeated from time to time. Many of our current members took courses from John O'Sullivan and others 30 years ago. While I believe the courses are valuable both to impart knowledge and popularize prospecting cost is a major issue.

An economical way to solve the apparent decline in prospector numbers may be the distribution of a pamphlet at events where the NSPA has a presence. The pamphlet should contain information on how to obtain a Prospectors Identification Card and directions to the on line Nova Scotia Prospectors Education Program. (The Prospectors ID card may be obtained as part of the prospector registering with NovaRoc,) A suggestion to consult You tube videos on gold panning and prospecting would be helpful as well.

The pamphlet probably should contain a list of useful DNR references and necessary literature. A list of basic prospecting equipment with suggested sources may be helpful as well.

The NSPA could also promote prospecting by the use of essay contests in the schools. Significant prizes could be offered on a province wide contest. The contest could be advertised to the schools by email. Probably not many students would respond, but the advertisement of the contest would reach many and in the long term be useful to both the students and the NSPA.

The Christmas Party at Swiss Chalet 3434 Kempt Road. The event was well attended. Lindsay Allen is to be thanked for his support of the event.






